AUGUST POA MEETING

The August General Meeting will be held on **Saturday, August 25th at 8:30 am at the Garrett 8 Cinema.** Please mark your calendar and attend. It is a great opportunity to meet Garrett County and State of Maryland officials, DNR management, and your POA Board Members. Items of interest to Deep Creek property owners will be discussed and the floor is always open to questions or comments from our members.

LAKE DRAWDOWN

Carolyn Matthews, Deep Creek Lake Manager, is reminding everyone about this fall's drawdown for the purpose of making repairs to the power plant at the dam. On October 16th an additional 2 feet will be drawn down. This will occur very quickly, in about 7 to 8 days, and then the water level will be at the 2454 level instead of the 2456 level. At this point there will be no further drawdown. The lake will then be allowed to start to refill. For property owners this means that boat storage and dock pulls will happen sooner than normal. Marinas and companies that pull docks may want them out mid to late September, if not sooner. Plan accordingly. For more information, go to deepcreeklakepoa.com

EMS PANEL DISCUSSION

The major portion of the August General Meeting will focus on a panel discussion concerning the Emergency Medical Service in Garrett County. The objective of the POA is to insure that the residents of Garrett County receive timely responses from the Emergency Medical Service providers of Garrett County.

One Infrastructure component to insure the Quality of Life in the County is Emergency Medical and Fire Services. A priority is the EMS, which needs improvement in Response Time and an increase in personnel to be available at all times. The panel discussion will focus on the following questions:

A. Where are we now in EMS Services?

- B. Where do we want to go?
- C. What do we do to get there?

EMERGENCY AND FIRE SERVICES AREAS OF FIRST RESPONSE

The two first-responder fire companies for the Deep Creek Lake area are the Deep Creek Volunteer Fire Department and the Deer Park Volunteer Fire Department. The area served by the Deep Creek Volunteer Fire Department runs from Doerr Road north of McHenry to Sand Flat Road extending to the Paradise Point area. This includes Rock Lodge Road to Mosser Road and Glendale Road to North Glade Road, including Harvey's Peninsula. It also covers the entire body of water on Deep Creek Lake. The Deer Park Volunteer Fire Department covers the lake areas south and east of Sand Flat Road at the Boy Scout Road turnoff. This includes Thousand Acres, Turkey Neck, Green Glade, and Sky Valley, etc.

The lake areas served by the Northern Rescue Squad are the same as those covered by the Deep Creek Volunteer Fire Company. The lake areas covered by the Southern Rescue Squad are the same areas covered by the Deer Park Volunteer Fire Company.

RECREATIONAL TRAILS

The Garrett County Commissioners' Task Force on Recreational Trails has been and is currently working on trying to connect the existing trails in Garrett County to form a larger network of trails. As we do this, there are times when it is necessary to ask Private Landowners for Easements to cross their land. In working towards this goal, we ask the Recreational Users respect Private Landowners. While walking these trails, always stay with the confines of the trail, but if you want to leave the trail, always ask for written permission to access private land and please respect the six inch blue markings on trees, signifying a private boundary. Remember that private property does not have to be marked.

NEW DNR WORKBOAT

Roy Musselwhite (Park Service Associate) has provided the following information about the new workboat purchased by Deep Creek Lake NRMA in late 2006. This boat will be used to place navigational buoys and to install public docks along with patrolling the lake. It was built by Ottercraft of Kingston, Washington, has a 23-foot aluminum mono-hull, and is powered by an Evinrude E-tec 225 engine with a top speed of 38.5 mph. It is designed for a crew of four, has survey quality GPS, and has many other custom features. With a fully enclosed cabin, a removable side dive door, winch, 360-degree searchlights and extensive storage space for buoys, chain, and anchors, it will make many DNR jobs much easier and quicker.

ALLEGHENY HIGHLANDS CONSERVANCY

The Allegheny Highlands Conservancy is a new nonprofit organization dedicated to protecting and conserving the natural resources of the Allegheny Highlands region. As its President Kevin Dodge explained at the POA June Membership meeting, "AHC's mission is to promote the preservation, protection and stewardship of the forest, scenic, natural, wildlife, recreational and agricultural land and water resources of Garrett County and neighboring areas."

Recently AHC has been actively engaged in the development of Garrett County's proposed Comprehensive Plan. As a land trust, AHC also works with landowners to preserve forested and open spaces by accepting conservation easements. AHC holds its meetings on the third Wednesday of odd-numbered months at 7:00pm in the CAOS building of Garrett College. The next meeting will be September 19. GYPSY MOTHS: FUNDING FOR 2008 SPRAYING

The Garrett County Forest Conservancy District Board has been working in cooperation with the Maryland DNR Forest Service, the Maryland Department of Agriculture, the Garrett County Office of the University of Maryland Extension Service, the Garrett County Commissioners and many private forest owners to inform our citizens about the Gypsy Moth problem we are experiencing. Because the problem is so broad, not all areas were able to be sprayed this spring. The Extension Service will be conducting defoliation surveys to determine the damage and this fall it will be necessary for check for egg masses. Residents who wish to report damage may contact the Extension Office at 301-334-6960 or the Cumberland Office of the Maryland Department of Agriculture's pest control at 301-777-3601.
